This is in continuation to our previous intimations dated July 07, 2025, July 03, 2025 and other communications, we wish to inform that pursuant to effectiveness of the Composite Scheme of Arrangement between Antelopus Energy Private Limited (“**Transferor Company**”) and Selan Exploration Technology Limited (“**Transferee Company**” or “**Company**”), as approved by the Hon’ble National Company Law Tribunal, Chandigarh Bench, vide its order dated June 10, 2025 (as rectified by order dated July 01, 2025) received by the Company on July 03, 2025 and upon receipt of fresh Certificate of Incorporation dated August 12, 2025, issued by the Registrar of Companies, Central Registration Centre, Manesar (“**ROC**”) (copy enclosed as Annexure A), the name of the company stands changed from “Selan Exploration Technology Limited” to “Antelopus Selan Energy Limited” with effect from today i.e. August 12, 2025.
