2. The company operates under single segment viz., Power and thus the IND AS 108- Operating Segment Reporting does not apply.

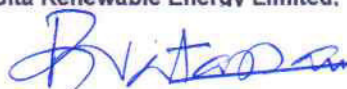
3. The Statement of Assets and Liabilities as at September 30, 2025 has been annexed.

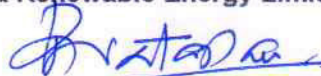

To The Board of Directors **GITA RENEWABLE ENERGY LIMITED**

We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of GITA RENEWABLE ENERGY Limited ("the Company") for the Quarter ended September 30, 2025 and year to date from 1st April 2025 to 30th September 2025 (hereinafter referred to as the "Statement"), attached herewith.
