This letter is to formally withdraw the request for reclassification of B.C. POWER CONTROLS LIMITED, from the "Promoter/Promoter Group" category to the "Public" category, as initially communicated to the BSE Limited on 06th November 2025

Power Controls Limited, had previously submitted a request for reclassification, citing we are not, directly or indirectly, associated with the business of the Company and do not have any influence over the business and policy decisions made by the Company.
