Further to our letter dated January 08, 2026, we wish to inform you that Sagar Cements Limited, being the Promoter of Andhra Cements Limited (the "Company"), has sold 71,48,978 equity shares of the Company having face value of ₹ 10/- each (representing 7.76% of the total issued and paid-up equity share capital of the Company) on January 09, and 12, 2026, by way of Offer for sale of shares through stock exchange mechanism in accordance with SEBI Circular No. SEBI/HO/CFD/PoD2/P/CIR/2023/18 dated February 3, 2023 to achieve the Minimum Public Shareholding requirements.

With the aforementioned sale, the shareholding of the Promoter in the Company has reduced from 90% to 82.24% of the paid-up equity share capital of the Company.


Accordingly, the public shareholding of the company increased from 10.00% to 17.76% and is in the process of achieving the Minimum Public Shareholding requirements of 25% within the stipulated time period to meet the regulatory requirement under rules 19(2)(b) and 19A of the Securities Contracts (Regulation) Rules 1957, read with Regulation 38 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

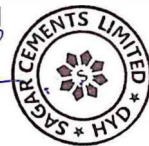
