

Gaurav Munjal to stay at the helm of Unacademy

UNACADEMY CO-FOUNDER GAURAV MUNJAL will continue to lead the edtech company as group chief executive, ending months of speculation over a potential leadership transition at the SoftBank-backed test preparation firm, people familiar with the matter told FE.

The decision comes days after acquisition talks between Unacademy and Ronnie Screwvala-led upGrad collapsed over valuation differences. The two sides were unable to agree on terms for what was envisaged as an all-stock transaction valuing Unacademy at about \$300 million—nearly 90% discount to its peak valuation of \$3.4 billion in 2021.

The failed upGrad talks mark the second high-profile acquisition attempt involving Unacademy in the past 14 months. In late 2024, the company was reported to be in advanced discussions to be acquired by Kota-based Allen Career Institute at a valuation of around \$800 million, but those negotiations also fell through amid disagreements over valuation and share-swap ratios.

Last month, during a town hall and in a detailed post on X marking Unacademy's 10th anniversary, Munjal publicly acknowledged the sharp fall in the company's valuation, saying the group was now likely worth less than \$300 million.

Under the proposed upGrad transaction, Munjal and co-founder Roman Saini had planned to step back from operational roles. With the deal no longer proceeding, both founders are expected to remain and continue running the business, the people said.

Munjal is now expected to focus on strengthening Unacademy's online businesses, with AirLearn, its language-learning app, identified as a key priority. "The immediate focus will be on restoring the company's emphasis on online businesses," one of the people said.

AirLearn has emerged as the group's fastest-growing business. As of April last year, the app had reached annual recurring revenue (ARR) of about \$2 million, with roughly 70,000 daily active users.

By September, the platform reported more than 10 million lessons completed within a 30-

and co-founder Roman Saini had planned to step back from operational roles. With the deal no longer proceeding, both founders are expected to remain and continue running the business, the people said.

Two of Unacademy's online-focused verticals—Graphic, its creator platform, and PrepLadder, its medical entrance exam preparation business—are already profitable, sources said. Munjal had said as early as April last year that both units were generating positive monthly cash flow.

On the offline front, Unacademy operates 26 company-owned coaching centres alongside 35 franchise locations. "In offline, the focus has been on achieving profitability. Around 90% of centres are profitable at the centre-level," sourced added.

Losses across both online and offline test preparation segments have narrowed sharply. The company's cash burn has fallen from about ₹1,400 crore in 2022 to roughly ₹150 crore in 2025,

they added. The offline business currently accounts for around 80% of the group's cash burn. Unacademy had approximately ₹1,070 crore in cash on its balance sheet.

The Bengaluru-based company reported revenue of ₹826 crore in FY25, up 16% from ₹988 crore in FY24.

Net losses narrowed to ₹436 crore from ₹631 crore a year earlier, extending a trend of improving unit economics after losses peaked at ₹82,848 crore in FY22.

The company's headcount stood at about 1,800 employees as of July 2025, down roughly 30% year-on-year (y-o-y) from around 2,600 in 2024. The company has carried out multiple performance-linked workforce reductions as part of its cost optimisation efforts.

Battery plant plans back on track: RIL

RELIANCE INDUSTRIES ON Monday said its plans for battery storage manufacturing remain unchanged and are progressing in line with target timelines.

Commenting on reports of the conglomerate pausing plans to make lithium-ion battery cells in India after failing to secure Chinese technology, a company spokesperson said, "We would like to categorically affirm that there has been no change in our plans for creating a world leading battery storage manufacturing ecosystem from cell to containerised ESS, and they are progressing well in line with our target timelines."

The company had previously indicated 2026 as the target to begin manufacturing battery cells.

Its chairman and managing director Mukesh Ambani had in August last year told shareholders that Reliance's battery mega factory will start in 2026, and that it will begin with 40 GWh per year capacity and expand modularly to 100 GWh per year.
