We wish to inform you that the Board of Directors ("Board") of the Company at its meeting held today i.e. January 13, 2026, has considered and analysed the request letters dated November 17, 2025, November 18, 2025, November 20, 2025, and November 28, 2025 received from following members of Promoter Group as enlisted below seeking re-classification from 'Promoter Group' category to 'Public' category, under Regulation 31A of the Listing Regulations, 2015.

The Board noted that, the above-mentioned Promoter Group in their respective requests have confirmed that;

- a) They do not, together hold more than ten percent of the total voting rights in the Company;
- b) They do not exercise control over the affairs of the Company directly or indirectly;
- c) They do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
- d) They do not represent on the board of directors (including as a Nominee Director) of the Company;
- e) They do not act as key managerial personnel in the Company;
- f) They are not a 'wilful defaulter' as per the Reserve Bank of India guidelines;
- g) They are not a fugitive economic offender.

The Board also noted that, pursuant to Regulation 31A(3)(a)(vi) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the approval of shareholders in relation to the reclassification is not applicable to the Company as member of the promoter group seeking reclassification and persons related to them, together, do not hold more than one percent of the total voting rights in the Company.
