Sub: Update –Acquisition of residual stake in NTT Data Payment Services India Private Limited (formerly known as NTT Data Payment Services India Limited and prior to that, ATOM Technologies Limited) by NTT Data Group Corporation, from 63 moons technologies limited (63 moons).

Further to our letter dated September 27, 2019, we hereby intimate you that pursuant to Hon’ble MPID Court’s Order, 63 moons has entered into a Share Purchase Agreement on 13.02.2026 with NTT Data Group Corporation and NTT Data Payment Services India Private Limited, for the sale of its residual shareholding of 21,00,86,610 equity shares in NTT Data Payment Services India Private Limited (an Associate of 63 moons) for an aggregate consideration of USD 18,432,925. As directed by the MPID Court’s Order, on receipt of the said consideration amount, 63 moons shall deposit the INR equivalent of the said consideration amount, after deducting applicable taxes, in the designated bank account of the Competent Authority NSEL MPID as security in lieu of attachment.
