AF chief Air Chief Marshal A P Singh himself flew a C-130J 'Super Hercules' aircraft from Hindon on the outskirts of Delhi to the Mudh airfield at Nyoma, among the world's highest at an al titude of 13,710-feet, to formally in augurate the strategic airbase. He
