1. We have reviewed the accompanying statement of Unaudited Standalone Financial Results of Manor Estates and Industries Limited ('the Company') for the quarter and half year ended 30th September, 2025, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), including relevant circulars issued by the SEBI from time to time (the listing Regulations).
