We have reviewed the accompanying Statement of Unaudited Financial Results of "**Lyons Corporate Market Limited**" (hereinafter referred to as 'the Company'), (**CIN - L74140WB1994PLC061497**), for the half year ended September 30, 2025 ("the Statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
