**INDEPENDENT AUDITORS' REVIEW REPORT ON REVIEW OF INTERIM FINANCIAL RESULTS**


**To the Board of Directors of M/s S.I. CAPITAL & FINANCIAL SERVICES LIMITED**

1. We have reviewed the accompanying Statement of Unaudited Financial Results of **S.I.CAPITAL & FINANCIAL SERVICES LIMITED** ("the Company") for the quarter and half year ended 30<sup>th</sup> September 2025 attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the Regulation") as amended.
