सुप्रीम कोर्ट ने सोमवार को केंद्र से सुनिश्चित करने को कहा कि शीर्ष अदालत के कालेजियम द्वारा की गई सिफारिश के अनुसार न्यायाधीशों की नियुक्ति और ट्रांसफर से जुड़े मुद्दों पर जो कुछ किए जाने की उम्मीद है, उनमें से ज्यादातर कर लिया गया है। न्यायमूर्ति एसके कौल, न्यायमूर्ति मनोज मिश्रा और न्यायमूर्ति अरविंद कुमार की पीठ ने कहा कि वह जजों की नियुक्ति से जुड़े कुछ मुद्दों को लेकर चिंतित है। अटार्नी जनरल आर वेंकटरमणी के

अदालत में उपस्थित नहीं रहने के कारण पीठ ने दो याचिकाओं की सुनवाई दो मार्च के लिए स्थगित कर दी। इनमें से एक याचिका में आरोप लगाया गया है कि केंद्र कालेजियम द्वारा सिफारिश किए गए नामों की मंजूरी देने में देर कर रहा है। अटार्नी जनरल की ओर से उनके सहायक वकील द्वारा कुछ समय मांगे जाने पर पीठ ने कहा-कृपया यह

सुनिश्चित करें कि जो कुछ किए जाने की उम्मीद है, उनमें से ज्यादातर कर लिया गया है। एक याचिकाकर्ता की ओर से पेश हुए वरिष्ठ वकील प्रशांत भूषण ने पीठ से कहा कि कुछ नियुक्तियां चुनिंदा तरीके से अधिसूचित की जा रही हैं। जबकि कुछ को लंबित रखा जा रहा है। न्यायमूर्ति कौल ने कहा-मैं यह मुद्दा पहले ही उठा चुका

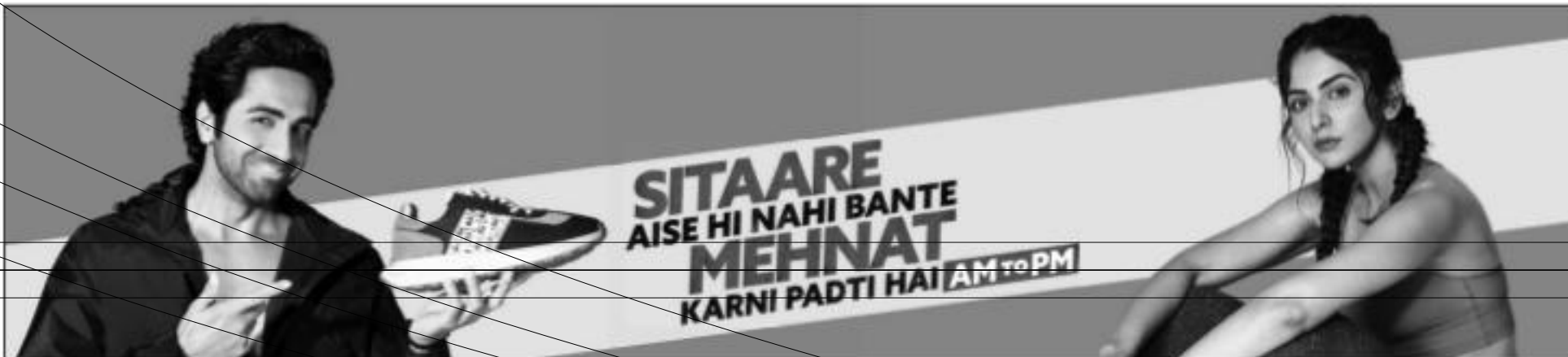
