The Management of the Company is responsible to ensure the compliance with the requirements of the act and the rules relating to voting through electronic means on the resolution contained in the Postal Ballot Notice dated March 07, 2025. Our responsibility as a Scrutinizer for the e-Voting process is restricted to make a report on the votes cast "in favour" or "against" the said resolution, based on the reports generated from the e-Voting system provided by National Securities Depository Limited (NSDL), the authorized agency to provide e-voting facilities, engaged by the Company.

The Company has availed the E-voting facility offered by the National Securities Depository Limited (NSDL) for conducting remote e-voting by members of the Company. The Company has also provided an option for remote e-voting to those shareholders who held shares in Physical form.

The remote e-voting portal remained open for voting from Tuesday, March11, 2025, at 9:00 A.M. IST and ended on Thursday, April 10, 2025, at 5:00 P.M. IST (both days inclusive).
