JOHANNESBURG At least 42 killed in



At least 42 people were killed in a bus crash in a mountainous region of northern South Africa, authorities said on Monday. The crash happened on Sunday on the N1 highway near the town of Louis Trichardt, around 400 kilometres (248 miles) north of the capital, Pretoria. Simon Zwane, a Road Traffic Management Corporation spokesperson. told South Africa's News24 news outlet that authorities had confirmed 42 fatalities but were still verifying the number of dead and injured. The bus veered off the road along a steep mountain pass and plunged into an embankment, the provincial government said.

Six workers die in mine collapse

Six workers were killed when the mine they were working in collapsed due to an explosion in Kurram district of Pakistan's Khyber Pakhtunkhwa province, rescue officials said on Monday. The incident occurred in Tora Warai, central Kurram district, on Sunday, when a section of the mine collapsed after a blast, causing a sudden rise in water level. According to rescue officials, the blast triggered a surge in underground water, which forced the mine to cave in. The collapse occurred shortly after the explosion, leaving the mine workers stuck inside, the police said.

Eyes on Gaza peace path

President Donald Trump arrived in Egypt on Monday for a global summit on Gaza's future as he tries to advance peace in the Middle East after visiting Israel to celebrate a US-brokered ceasefire with Hamas. More than two dozen countries are expected to be represented at the summit, which Trump is hosting along with Egyptian President Abdel-Fattah el-Sissi. Israeli Prime Minister Benjamin Netanyahu was invited but declined, with his office saying it was too close to a Jewish holiday.

2 lawmakers hold up signs in disruption bid, swiftly sent out of hall

JERUSALEM

Two Knesset members on Monday were swiftly expelled by ushers as they tried to disrupt US President Donald Trump's address in the Israeli Parliament.

A few minutes after Trump began addressing the Knesset, the two members rose with signs held in their hands.

"That was very efficient of you", Trump praised the ushers who removed Knesset members Avman Odeh and Ofer Cassif from the plenum hall after they held up signs during the president's speech.

The special session of the Knesset was being held in honour of the President of the USA on a day the Hamas released the remaining hostages abducted during the October 7, 2023 attacks.

"People will remember this as the moment when everything started to change for the better. It will be the golden age of Israel and the Middle East," Trump said while also thanking the Arab countries that helped sign the peace deal.

Trump received a standing ovation at the Knesset address following the ceasefire deal reached between Israel and Hamas.

Trump to get highest Israel civilian award

TEL AVIV: Prime Minister Benjamin Netanyahu on Monday nominated US President Donald Trump for the Israel Prize, the country's highest civilian honour, hailing him as "the greatest friend that Israel has ever had in the White House."

"I have seen many US presidents, but I have never seen anyone move the world so quickly and decisively,' Netanyahu said in his address.

Netanyahu also praised Trump's record on Israel, including his recognition of Jerusalem as Israel's capital. relocation of US embassy, acknowledgement of Israeli sovereignty over Golan Heights, support at the UN, and his role in initiating the Abraham Accords.

President Donald Trump on Sunday warned Russia that he may send Ukraine longrange Tomahawk missiles if Moscow doesn't settle its war there soon - suggesting he could be ready to increase the pressure on Vladimir Putin's government using a key weapons

"I might say, 'Look: if this war is not going to get settled, I'm going to send them Tomahawks," Trump told reporters aboard Air Force One as he flew to Israel. "The Tomahawk is an incredible weapon, very offensive weapon. And honestly, Russia does not need

well." He added, "We may not, but we may do it. I think it's appropriate to bring up."

His comments came after Trump spoke by phone earlier on Sunday with Ukrainian President Volodymyr Zelenskyy, and Trump said he mentioned possibly sending Tomahawks during that conversation. "Do they want to have Tomahawks going in that direction? I don't think so," Trump said of Russia, "I think I might speak to Russia about that." He added that "Tomahawks are a new step of aggression." His suggestions followed Russia having attacked Ukraine's power grid overnight, part of an ongoing campaign to cripple Ukrainian energy infrastructure before winter. Moscow also expressed "extreme concern" over the US potentially providing Tomahawk cruise missiles to Ukraine.

Putin himself has previously suggested that the United States supplying long-range missiles to Ukraine will seriously damage relations between Moscow and Washington.

Zelenskyy described his latest call with Trump as "very productive," and said the pair had discussed strengthening Ukraine's "air defence, resilience, and long-range capabilitie."

Madagascar prez may have fled post coup, reports swirl

ANTANANARIVO

Madagascar President Andry Rajoelina was due to make a speech on national television on Monday after an elite military unit turned against the government in an apparent coup in the Indian Ocean nation and called for Rajoelina to step down.

Rajoelina's office said that his speech would be broadcast on state television and radio at 7 pm local time (1600 GMT), but didn't say if the president was still in Madagascar amid reports he had fled following weeks of deadly anti-government protests.
