Collector inspects revision of electoral roll in Villupuram

Villupuram, Nov 14; Villupuram District Election Officer and District Collector Mr. She. Sheik Abdul Rahman, I.A.S., inspected several locations on 13.11.2025 to review the ongoing Intensive Special Summary Revision (SSR) of the Electoral Roll across the seven Assembly constituencies in the district.

The District Election Officer stated that the Intensive Special Revision has begun in all constituencies as instructed by the Election Commission of India. A consultation meeting with recognised political party representatives was conducted on 29.10.2025, followed by training sessions for Booth Level Officers (BLOs) under the guidance of the Electoral Registration Officers (EROs).

The special revision process has reached its 10th day in the following constituencies:

- 70 – Gingee, 71 – Mailam, 72 – Tindivanam, 73 – Vanur, 74 – Villupuram, 75



– Vikravandi, and 76 – Tirukkoyilur.

Inspection activities took place at the Kandachipuram Taluk Office, NGGO Nagar in Tirukkoyilur Municipality, and the Tirukkoyilur Taluk Office. BLOs were observed updating voter details using the BLO mobile application.

The District Collector highlighted that BLOs have already received detailed training for the revision work. Each voter is required to be given two copies of the enumeration form as per Election Commission guidelines. BLOs must

visit every household, collect accurate voter information, and return with one completed form while the voter retains the other.

Necessary details such as the voter's name, part number, and relationship information must be entered correctly. Verification of data linked to the 2002 voter list is also required.

The enumeration drive began on 04.11.2025 and will conclude on 04.12.2025. BLOs have been instructed to distribute, collect, and

verify the forms within this period. The District Election Officer urged all field staff to complete the tasks efficiently and within the scheduled timeline.

Officials present during the inspection included Tirukkoyilur Sub-Collector Mr. Anand Kumar Singh, I.A.S., Kandachipuram AERO Mr. Muthu, Tirukkoyilur AERO Mr. Saravanan, Special Tahsildar (Election) Mrs. Jayalakshmi, and Tirukkoyilur Municipal Commissioner Ms. Divya, along with several others.
