Sub: Regulation 29(2) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011

We refer to our letter dated June 16, 2011, to inform you that as of June 14, 2011, the total holding of the Schemes of HDFC Mutual Fund (referred to as "the Fund") in "KNR Constructions Limited" (referred to as "the Company") was 7.61% of the Company's paid-up equity share capital, which amounts to Rs. 28,12,34,600/- comprising 2,81,23,460 equity shares of Rs. 10/- each. Furthermore, considering the latest capital of Rs. 56,24,69,200/- comprising 28,12,34,600 equity shares of Rs. 2/- each, the aforementioned aggregate holdings now stand at 0.76%.

Accordingly, as on November 11, 2025 the aggregate holding of the Schemes of HDFC Mutual Fund in the Company is 5.45% of the paid up equity share capital of the Company (Rs. 56,24,69,200/- comprising 28,12,34,600 equity shares of Rs. 2/- each).
