Pursuant to the provisions of Regulation 30 read with sub-para 20, Para A of Part A of Schedule III of the Listing Regulations, we hereby submit the disclosure regarding the demand notice received by the company from TGSPDCL (Telangana State Southern Power Distribution Company Limited), on 13th November 2025 pertaining to Wheeling Charges for the FY2004-05 to FY2013-14 amounting to Rs.916,27,339/- together with surcharge aggregating to Rs.12,59,24,552/- at our hotel Taj Deccan, Hyderabad.

The company procured Electricity from 3rd party producers i.e. Ind Barath Energies Limited during that period. Initially the company filed the writ petition in Hon'ble High court of Telangana in the year 2020 and recently the Hon'ble High Court passed order in favor of the TGSPDCL in connection with the collection of wheeling charges from the recipient. The company is confident that the wheeling charges are to be paid by the third-party producer and not by the recipient.

We are in the process of filing an Appeal with the Hon'ble High Court of Telangana for a stay on the recovery of the demand and are confident of obtaining a favorable order.

You are requested to kindly take the same on record.
