1. INCREASE IN AUTHORISED SHARE CAPITAL

Increase in Authorised Share Capital of the Company from Rs.12,00,00,000 (Rupees Twelve Crores Only) divided into 12,00,00,000 (Twelve Crores) Equity Shares of Re. 1/- each to Rs. 36,00,00,000/- (Rupees Thirty-Six Crores Only) divided into 36,00,00,000 (Thirty-Six Crores) equity shares of Re. 1/- each by creating additional Rs. 24,00,00,000 (Rupees Twenty-Four Crores Only) Equity Shares of Re. 1/- each ranking pari passu with the existing Equity Shares of the Company.”.
