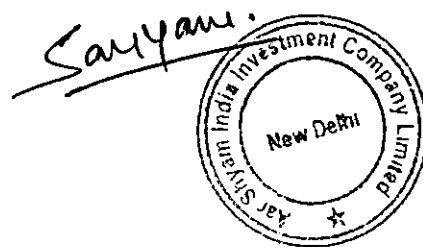

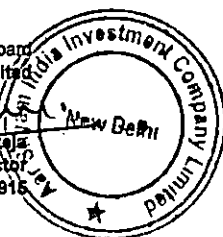

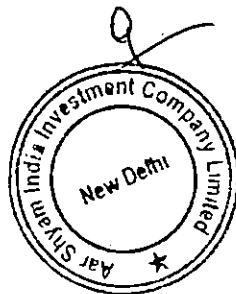
Review Report to
