The Securities and Exchange Board of India ("SEBI") vide gazette notification dated June 08, 2018 and vide its press release dated December 03, 2018, amended Regulation 40 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and has mandated that the transfer of securities would be carried out in dematerialized form only w.e.f. Accordingly, on the basis of examination of the relevant documents relating to shares of **SEA TV NETWORK LIMITED** ("the Company"), having its registered office at 148, Manas Nagar, Shahganj, Agra- 282010 (Uttar Pradesh) INDIA and paid up share capital of Rs. 1,202,00,000/- (Rupees Twelve Crore Two Lacs only) divided into 120,20,000 (One Crore Twenty Lacs Twenty Thousand only) equity shares of Rs. 10/- (Rupees Ten only) each, maintained and provided electronically by LINK INTIME INDIA PRIVATE LIMITED., Registrar and Transfer Agent (RTA), pertaining to the period from October 01, 2020 to MARCH 31, 2021 for the purpose of issuing a Certificate as per Regulation 40(9) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, We hereby certify that:
