CII Launches national innovation challenge

Chennai, Jun 14: The Confederation of Indian Industry (CII) launched a national initiative CII-ASCEND: Activate Startups in CleanTech to Strategize, Execute, Navigate & Deploy. It serves as a platform for driving cleantech innovation through collaboration and bringing together all stakeholders – innovators, industry leaders, incubators & accelerators, investors, and ecosystem enablers to collectively accelerate the adoption of clean technologies in the Indian Industry. The initiative was formally launched by Shri D. Sridhar Babu, Hon'ble Minister for Information Technology, Electronics & Communications; Industries

& Commerce and Legislative Affairs, Government of Telangana, at the CII-GreenCo Summit 2025 in Hyderabad. The 1st edition of the CII-ASCEND Innovation Challenge is being rolled out with support from the Sustainability, Equity and Diversity Fund (SED). It offers a unique opportunity for cleantech innovators to gain national visibility, industry validation, and critical deployment support for real-world pilots. The challenge is open to Indian CleanTech startups, technology providers, public R&D labs, technical institutes, universities, MSMEs, and government-affiliated research

Solutions must be at Technology Readiness Level (TRL) 5-7 and demonstrate strong potential for scale, with no adverse environmental or safety impacts. The challenge now invites applications across a wide spectrum of clean technology domains that can drive sustainability in Indian industry. Priority thematic areas include energy efficiency, water management, waste management, renewable energy, IoT solutions, resource efficiency, decarbonization solutions, energy storage, green hydrogen, electric vehicles & infrastructure, circular economy, low carbon materials and many more.

British Council hosts Zaat by Sonakshi Chaturvedi

New Delhi, Jun 14: The Gallery at the British Council, Kasturba Gandhi Marg, will host "Zaat" by Sonakshi Chaturvedi from June 11 to July 31, 2025, as part of the Study UK: Creative Connections II programme. This sculptural installation delves into matrimonial memory, blending heirloom objects with metal, enamel, and gemstones to reflect on women's histories often lost or reduced to roles of bride, mother, and grandmother. A graduate of the Royal College of Art, London, and a trained gemologist, Sonakshi fuses traditional craftsmanship with contemporary art to question cultural inheritance in South Asian societies. Inspired by her

grandmother's wedding trousseau, her works feature metallic, time-worn exteriors that conceal vibrant, candy-like interiors—symbolising hidden desires and unspoken agency across generations of women. "Zaat began as a personal act of reclaiming forgotten voices, transforming heirlooms into archives of silent resistance," says Chaturvedi. Part of the British Council's Best of British series, the exhibition highlights the global impact of UK-educated artists fostering cross-cultural dialogue. Chaturvedi continues to explore enamel and gemology practices in the UK while preparing for doctoral research on craft, culture, and gender identity.

Insurers simplify claim process for Air India AI 171 crash victims

zChennai, June 14: In the wake of the tragic Air India Flight AI 171 crash in Ahmedabad, insurers including LIC and Bajaj Allianz have announced special measures to ease claim procedures for affected families. LIC stated it will expedite settlements by relaxing documentation norms. Instead of a formal death certificate, an official government record citing the passenger's death or proof of compensation from government or airline authorities will be accepted as valid evidence. "LIC is committed to providing swift financial relief by simplifying claims to reduce hardship for families," the company said in its statement. Private insurer Bajaj Allianz has also adopted similar relaxations, with further details to be announced. These steps are aimed at ensuring faster support to grieving families as investigations into the crash continue and relief efforts are underway.



As part of Viksit Krishi Sankalp Abhiyan 15 days long special campaign was organised by delivering suitable technologies to reap more income from kharif season crops. This nationwide special drive has been launched by the Minister for Agriculture and Farmers Welfare Sivraj Singh Chouhan and closed the event on 12th June 2025.

Sterling Holidays supports lifesaving dialysis access through CSR initiative

Chennai, June 14: Sterling Holidays Resorts has reinforced its commitment to community health by supporting the FICF Dialysis Mission, an initiative by the Fairfax India Charitable Foundation (FICF) to expand access to dialysis care in underserved regions. In FY 2024-25, Sterling funded Rs.7.5 million for 16 dialysis machines across seven centers in Tamil Nadu, Madhya Pradesh, and Assam. For FY 2025-26, the company has pledged Rs.15 million more to install 22 additional machines near its resort locations. Altogether, these 38 machines are expected to provide over

18,000 free or subsidized dialysis sessions, saving patients an estimated Rs.36.4 million in treatment costs. "This reflects Sterling's belief that hospitality brands can drive social impact beyond business," said Vikram Lalvani, MD & CEO, Sterling Holiday Resorts. The FICF Dialysis Mission, executed via a

Public-Private Partnership (PPP) model, plans to deploy 2,000 machines in 450 centers across 350 districts, aiming to deliver 4.5 million low-cost dialysis sessions, save Rs.920 crore for patients, and generate 4,500 rural jobs.
