Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	Prima facie, there may an impact on the Financial or operation or other activities as the main data centre of the Company has been seized and that the company is trying to assess the extent of such impact. We shall inform the exchange in case of any developments or assessment.  The authority has seized the Bhiwadi data centre belonging to Company amounting to INR 9,25,00,000/- along with certain movable assets, contracts, intellectual property, books and records, insurance policies, and digital data related to the Company.  These shall be retained by the authority only for the duration necessary for the purpose of examination or enquiry.

The Company shall continue to operate in normal course of business and shall co-operate with the authorities during the investigation and shall provide all relevant information to the authorities as and when requisitioned and available with the Company.

The Company further clarifies that the search was carried out with respect to the ongoing investigation in the matter of Vuenow Marketing Services Limited as clarified in the Press release filed with the exchange on January 23, 2025 and March 03, 2025.
