Hon'ble High Court of Delhi, also dismisses the petition filed by Mr. Robin Raina against Eraaya Lifespaces Ltd

New Delhi, September 15, 2025 – Mr. Robin Raina's petition to assert his purported claim in the ownership of Eraaya Lifespaces Ltd and its Global Subsidiaries operating under Ebix Inc., including half a dozen applications seeking various interim reliefs and repeated adjournment requests, have all been Dismissed by the Hon'ble High Court of Delhi.

This Dismissal Order has been passed in the backdrop of the fact that Mr. Robin Raina, former CEO of Ebix Inc. had filed a Petition before the Hon'ble Supreme Court of India, wherein after hearing arguments, vide Order dated 25.08.2025, the Hon'ble Supreme Court's Bench lead by the Hon'ble Chief Justice of India, had also dismissed his pleas. Thereafter also, the Hon'ble Delhi High Court had once adjourned the hearing on his request, before dismissing his petition.

Eraaya's legal team lead by Sh. Mukul Rohatgi, Learned Senior Advocate and former Attorney General of India as well as Dr. Abhishek Manu Singhvi had earlier also argued before the Hon'ble Delhi High Court that the alleged claims of Mr. Raina were premised on a forged document(s) and all his claims were nothing but an utter commercial nonsense.

Over the past more than a year, all of Mr. Raina's attempts to destabilise Eraaya and its Global Subsidiaries operating under Ebix Inc, have remained futile exposing the sham of his purported claims, reaffirming Eraaya's position.
