The entire operation of the Company relate to only one segment viz. supply of construction and real estate related materials. Hence, as per the Management approach under Ind AS - 108, the company has a single operating segment. 4. Figures for the Previous period /quarter have been rearranged/re-grouped wherever necessary, to conform with the figures for the current year/quarter. 5. The management have filed an application with NCLT against three parties covering the receivables of Rs. 82.63 Million , the said matter has been resolved during this period through settlement, wherein the Company has received Rs. 40.00 Million through demand drafts and, in lieu of the remaining Rs. 40.00 Million , four residential flats (2 BHK each) located at Bhandup have been allotted by the creditors, for which allotment letters have been issued. The balance amount of Rs. 2.63 Million has been considered as loss and will be accounted for upon transfer of ownership of the said flats in the name of the Company. 6. These financial statements have been prepared on a going concern basis, despite accumulated losses and a negative net current asset position as of the balance sheet date. Management is optimistic about the company's revival in the coming years, citing the exits of residential projects and a reduction in debt. Consequently, these financial statements do not include any adjustments related to the recoverability and classification of assets or liabilities that might be necessary if the Company were unable to continue as a going concern.
