Pakistani security forces killed 26 terrorists in multiple intelligence-based operations in the restive Khyber Pakhtunkhwa province, officials said on Friday.

The three operations were conducted in the Bajaur, Kohat and Karak districts on Thursday.

The operation in Bajaur was conducted after receiving credible information about the presence of a large number of terrorists in the Gaddar village. "As soon as the information was received, the forces carried out an extremely effective and targeted operation, during which 22 terrorists were killed," a security official said.

The terrorists were in the village which had already evacuated the cooperation of elders.

"At the time of the operation, all the around the target were due to which no civilian harmed," the security added.
