AFTER 43 DAYS: US Prez signs bill marking an end to longest shutdown in the history of America

US GOVT REOPENS

WASHINGTON [US]

US President Donald Trump signed into law the funding package to reopen the federal government, officially ending the longest shutdown in American history, which lasted 43 days. Speaking from the Oval Office on Wednesday, Trump blamed Democrats for the impasse, calling it an attempt to "extort American taxpayers.'

"For the past 43 days, Democrats in Congress shut down the government of the United States in an attempt to extort American taxpayers for hundreds of billions of dollars for illegal aliens. Today, we're sending a clear message that we will never give in to extortion," Trump said.

The signing came shortly after the House of Representatives approved the funding package 222-209, following the Senate's earlier passage. Nearly all Republicans and a few Democrats voted in favor, ending weeks of bitter deadlock over an Obamacare-related program opposed by Repub-

California revokes 17K immigrant **CDL** licences

New York: California plans to revoke 17,000 commercial driver's licenses given to immigrants after discovering the expiration dates went past when the drivers were legally allowed to be in the US, state officials said on Wednesday. The announcement follows harsh criticism from the Trump administration about California and other states granting licenses to people in the country illegally. The issue was thrust into the public's consciousness in August, when a tractortrailer driver not authorised to be in the US made an illegal U-turn and caused a crash in Florida that killed three people. Transportation Secretary Sean Duffy said California's decision to revoke the licenses admits the state acted improperly, despite earlier defending its standards.

War to continue, Ukraine rejects Russia's talk offer

Kremlin spokesperson Dmitry Peskov has said that Ukraine's reluctance to engage in dialogue leaves Russia no choice but to continue pursuing its objectives through military means.

The comments follow Ukrainian Deputy Foreign Minister Sergey Kislitsa's statement on Tuesday that Kiev has "abandoned" direct talks with Moscow after three rounds of negotiations in Istanbul, citing "little progress." No further meetings have taken place since late July.

Peskov told reporters on Thursday that Kislitsa's remarks "formalize the de facto situation" in which Ukraine is unwilling to maintain contact. He called the situation "sad" and said that, in the absence of continued dialogue, Russia would "continue the military operation in every possible way."

NATO member refuses to back **EU** attack on Russian assets

Agencies BRUSSELS

Norway will not tap its massive sovereign wealth fund to act as a financial backstop for a proposed EU loan to Ukraine based on Russian assets frozen by the bloc, Fi-Minister Jens nance Stoltenberg has said.

Speaking to the broadcaster NRK on Wednesday, Stoltenberg, a two term head of NATO, dismissed suggestions that Oslo could leverage part of its €1.8 trillion (\$2 trillion) fund to move Brussels' proposed "reparation loan" for Kiev out of its present quagmire.

The idea had reportedly been floated in Norwegian media and backed by some local politicians ahead of a visit by Stoltenberg to Brussels on Wednesday.

"There have been suggestions that Norway should guarantee the entire amount,"
