Nithya Arulsundaram, Whole-Time Director and CFO of the Company and Shri P. Arul Sundaram, Managing Director of the Company.

The delay in disclosure arose due to an internal coordination gap during a transition in the Company's compliance function. The matter came to the attention of the Secretarial Department during internal coordination, following which prompt steps were taken to assess disclosure requirements and initiate appropriate disclosures.
