  Accordingly, the communication of assent or dissent of the Members took place through the
  remote e-voting system only.
- The company has completed the dispatch of notice of Postal Ballot on Wednesday, 12<sup>th</sup> November, 2025 electronically to all the members whose name appeared in the Register of members as on Friday, 07<sup>th</sup> November, 2025, the cut-off date. The Shareholders of the company holding the shares as on the "cut off" date were entitled to cast their vote on the resolutions through remote e-voting as contained in notice.
- The remote e-voting period has commenced from, Thursday, 13<sup>th</sup> November, 2025 at 9.00 A.M. (IST) and ended on Friday, 12<sup>th</sup> December, 2025 at 5.00 P.M. (IST) and the remote e-voting module was disabled thereafter.
- For the purpose of remote e-voting facility to be provided to its members, the company has availed the services of MUFG Intime India Private Limited ('MUFG Intime').
- After the conclusion of the e-voting period, the votes cast by the members through remote e-voting facility, were downloaded from the e-voting website of the MUFG Intime in presence of two witnesses viz. Ms. Deepika Sharma and Ms. Drishti Bhatia, who are not in the employment of the Company.
