China lays claim to Kashmir's Shaksgam Valley, says infrastructure construction justified

Chinese Foreign Ministry Spokesperson Mao Ning on Monday rejected India's claim to the Shaksgam Valley in Jammu and Kashmir.

"The territory you mentioned belongs to China. It's fully justified for China to conduct infrastructure construction on its own territory," Mao said when asked about border issues and the China-Pakistan Economic Corridor (CPEC).

The spokesperson further said that China and Pakistan had signed a boundary agreement in the 1960s and demarcated borders between the two countries and that the settlement was an exercise of the rights of two sovereign states.

According to a Global Times report, the Foreign Ministry Spokesperson further said the CPEC is an economic cooperation project intended to promote local economic and social development and improve people's livelihoods. Mao stressed that the border agreement between China and Pakistan, and the CPEC do not affect China's position on the Kashmir issue, adding that China's position on this matter has not changed.



The Shaksgam Valley, borders Xinjiang Province of the People's Republic of China (PRC) to the north, the Northern Areas of POJK to the south and west, and the Siachen Glacier region to the east.

Earlier on January 9, India firmly rejected China's infrastructure build-up through the China-Pakistan Economic Corridor (CPEC) in the Shaksgam Valley, terming it "illegal and invalid", while noting that the region is an "integral and inalienable part" of India.

During a weekly press briefing, Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal said that India has never recognised the "so-called" China-Pakistan boundary agreement of 1963 or the "so-called" CPEC.

"Shaksgam Valley is an Indian territory. We

have never recognised the so-called China-Pakistan boundary agreement of 1963.

We have consistently maintained that the agreement is illegal and invalid. We do not recognise the so-called China-Pakistan Economic Corridor either, which passes through Indian territory, which is under forcible and illegal occupation of Pakistan," Jaiswal said.

He reaffirmed that the Union Territories of Jammu and Kashmir and Ladakh are an integral and inalienable part of India, noting that New Delhi has "consistently protested" to the Chinese side on the matter and has further reserved the right to safeguard its interests.

"The entire UTs of J&K and Ladakh are an integral and inalienable part of India. This has been clearly conveyed to the Chinese and Pakistani authorities several times. We have consistently protested with the Chinese side for its attempts to alter the ground reality in the Shaksgam Valley. We further reserve the right to take necessary measures to safeguard our interests," the MEA Spokesperson added.

Iran Embassy in India says millions condemn US, Zionist regime for "state-sponsored terrorism" amid unrest

NEW DELHI: Iran's Embassy in India stated that millions of people across Iran have condemned what it described as state-sponsored terrorism by the United States and the Zionist regime.

In a post on X, Iran in India said, "Breaking now: #Iran speaks with one voice as millions nationwide condemn the state-sponsored terrorism of the United States and the Zionist regime."

The embassy's remarks came amid heightened tensions in Iran, as large-scale pro-Iran demonstrations were held across several cities and provinces, including Tehran, with tens of thousands taking to the streets to express support for the nation and denounce what authorities described as armed acts of "terrorism" by protesters who took to the streets against the current regime, Iranian state broadcaster Press TV reported.

According to Press TV, rallies were held in several areas, including Azerbaijan province and the central city of Arak. Visuals aired from the province showed massive crowds participating in rallies, waving national flags and chanting slogans in support of Iran, while condemning the violence and organised unrest that has gripped the country over the past 15 days.



Similar scenes were reported from Arak, where large numbers of demonstrators gathered for what were described as pro-Iran, anti-terror protests.

Press TV reported that the nationwide rallies were organised to reject what officials described as foreign-backed unrest and oppose alleged attempts to turn protests into violence. The demonstrations follow days of unrest in the Islamic Republic, after it witnessed anti-government rallies driven by soaring inflation, economic hardship and mounting public anger over governance.

Amid the unrest, at least 544 people have been killed and more than 10,681 individuals have been arrested and transferred to prisons, according to the Human Rights News Agency.

Against this backdrop, Iran's Foreign Minister Seyed Abbas Araghchi said that there was clear evidence "linking this deadly violence to Mossad terrorists," as reported by Press TV.

Araghchi was referring to a post by former US State Secretary and CIA Director Mike Pompeo, who on X on January 2 said, "The Iranian regime is in trouble. Bringing in mercenaries is its last best hope. Riots in dozens of cities and the Basij under siege - Mashhad, Tehran, Zahedan. Next stop: Baluchistan. 47 years of this regime; POTUS 47. Coincidence?" Pompeo added in the same post, "Happy New Year to every Iranian in the streets. Also, to every Mossad agent walking beside them," triggering speculation that the anti-government unrest could be foreign-backed, particularly by the US and Israel, to overthrow the Khamenei regime, which has been in power since 1979. As protests and counter-demonstrations continue across Iran, authorities have also addressed public concerns over disruptions linked to internet-related issues and their impact on key services.

केरल में माकपा की पूर्व विधायक आयशा पोट्टी कांग्रेस में शामिल हुईं

इस योजना ने न केवल गारंटीकृत रोजगार और न्यूनतम मजदूरी सुनिश्चित की, बल्कि पंचायती राज संस्थाओं को स्थानीय विकास कार्यों को लागू करने में भी सशक्त बनाया। उन्होंने याद दिलाया कि संयुक्त प्रगतिशील गठबंधन सरकार के दौरान श्रीमती सोनिया गांधी ने गारंटीकृत रोजगार को संवैधानिक संरक्षण दिलाया था। उन्होंने कहा, 'केवल कर्नाटक में ही मनरेगा के तहत हर साल करीब 6,000 करोड़ रुपये के कार्य हुए। स्थानीय पंचायत प्रतिनिधि परियोजनाओं का चयन करते थे और
