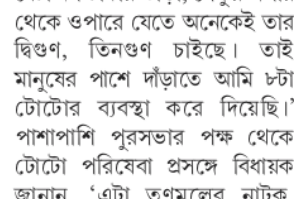
নার্সিংহোমে নার্সের বুলস্তু দেহ উদ্ধার
