Ex Municipal Commissioner, Civic Chief, arrested and remanded to ED custody

Mumbai, Aug 14 (UNI) : A special PMLA court here today remanded former Vasai-Virar City Municipal Corporation (VVMCC) commissioner Anil Paddy, suspended deputy director of town planning YS Reddy, builder Sitaram Gupta and his nephew Arun Gupta, to Enforcement Directorate (ED) custody till Aug 20 for their involvement in converting land meant for public use into private real estate.

The case was linked to the illegal construction of 41 buildings on 60 acres of government and private land reserved for public utilities in neighbouring Palghar district. All of them were arrested yesterday by ED and were produced under heavy police protection in the court this afternoon. They were earlier summoned to the central agency office in Mumbai for a joint interrogation. Over the past few months, the agency had recorded their statements, conducted searches, and compiled a detailed timeline of their alleged roles.

Officials said the questioning on Wednesday helped establish their involvement, following which they were taken into custody late in the evening under the Prevention of Money Laundering Act (PMLA).

The case stems from allegations that civic and town planning officials colluded with private developers as part of a powerful syndicate operating within the municipal body. According to the ED, the network included senior municipal officers, political figures, and rogue builders who allegedly conspired to convert land meant for public use into private real estate.

The agency has termed it a "deep-rooted nexus" that turned public land into a "private goldmine".

Marathi language must be learned and preserved, says Kripashankar Singh

Pune, Aug 14 (UNI) : Marathi is not just a language, it is our culture. If we do not learn the language of the state in which we live, we cannot truly understand the culture of that land. Nawab Malik appointed BMC Election Management Committee head

Mumbai, Aug 14 (UNI) : Following a prolonged political exile, Minister Nawab Malik was today appointed as the head of the Mumbai Municipal Corporation Election Management Committee by the Ajit Pawar-led Nationalist Congress Party (NCP) faction. Malik, who was recently inducted into the party, was assigned the responsibility during the core committee meeting. Malik, who had previously served a prison sentence in connection with alleged business links to underworld Don Dawood Ibrahim, was reportedly kept away from active politics due to pressure from the Bharatiya Janata Party (BJP) on the Ajit Pawar group. However, with the upcoming Mumbai civic polls, the party has reinstated him to an active role. As the committee's head, Malik will oversee seat selection, candidate nominations, campaign direction, and overall election strategy. If the Mahayuti alliance decides to contest the civic elections jointly, he will also be involved in seat-sharing negotiations with alliance partners.

NSIC collaborates with private banks to boost MSMEs' credit access



Mumbai, Aug 14 (IANS) : Government PSU, the National Small Industries Corporation (NSIC), signed Memorandums of Understanding (MOU) with several private sector banks to enhance the availability of credit for MSMEs under its MSME Credit facilitation programme, an official statement said.

The MOUs also aim to enhance accessibility and affordability of the credit to MSMEs, an official statement said.

The MOUs were signed with Axis Bank, Dhanlaxmi Bank, Karnataka Bank, AU Small Finance Bank, and IndusInd Bank, the release

said. Union MSME Minister Jitan Ram Manjhi and MSME Secretary S.L. Das were also present on the occasion. "The MoUs were exchanged between NSIC's Director, Finance, Gaurav Gulati and senior officials from various banks," the release said.

The collaboration aims to extend handholding support to MSMEs and help them link to the formal financial system.

The MOU focuses on the banks to expand their outreach to deserving micro & small enterprises, and the arrangement is expected to be a force multiplier in the efforts of banks to reach the

last mile, it added. This development aligns with Prime Minister Narendra Modi's recent calls for the "Vocal for Local" initiative. It encourages citizens and businesses to prioritise locally made products over imports to promote domestic manufacturing, create jobs, and boost the local economy. Pradhan Mantri MUDRA Yojana (PMMY), since its inception, has sanctioned 53.85 crore loans amounting to over Rs 35.13 lakh crore. The PMMY provides collateral-free credit up to Rs 20 lakh to micro and small enterprises, thereby enabling self-employment and income generation.

Jalgaon lynching sparks tensions; 8 arrested for killing youth

Jalgaon, Aug 14 (UNI) : A 21-year-old Muslim student and police aspirant, Suleman Rahim Khan Pathan, was brutally lynched by a mob of nine to fifteen men in Jalgaon district's Jamner taluka on August 12 this year. The attack took place just meters away from the Jamner police station, triggering widespread outrage and leading to the arrest of eight suspects.

Suleman, a resident of Chhoti Betawad village, had travelled approximately 20 kilometers to Jamner town that morning to submit his Maharashtra Police recruitment application after completing Class 12. Around 11:00 am, while seated at a café near the police station with a 17-year-old girl from another community, a mob forcibly dragged him into a vehicle. He was then subjected to hours of torture with sticks and iron rods for two days.

The assailants brought Suleman back to his village around 4:00 pm, where the fatal beating was conducted at the local bus stand. When his father Rahim Khan, mother, and sister rushed to intervene, the mob attacked them too with the same weapons. The perpetrators dumped Suleman's unconscious, battered body outside his home. Villagers rushed him to Jalgaon District Hospital, where doctors declared him dead on arrival.

"There was not a single inch on my son's body without wounds," his father Rahim Khan said. An in-camera post-mortem was conducted under police supervision to document the extensive injuries. Jamner Police Station registered an FIR

Police files cheating case against Shilpa Shetty and Raj Kundra

Mumbai, Aug 14 (UNI) : The Mumbai police's Economic Offences Wing (EOW) registered an FIR against the Bollywood actor Shilpa Shetty Kundra and her husband, Raj Kundra, for allegedly cheating a Juhu-based businessman of Rs 60.48 crore under the pretext of a business investment.

The FIR was first registered at Juhu police station, which is based on a complaint by Deepak Kohari (60), director of Lotus Capital Financial Services. Kohari alleged that between 2015 and 2023, he transferred Rs 60.48 crore to the couple's company, Best Deal TV Pvt. Ltd., for business expansion. However, the funds were allegedly diverted for personal expenses.

The investigation of the matter was handed over to EOW, as the sum involved in the crime is above Rs 10 crores. After conducting a preliminary inquiry, EOW registered the case under IPC sections 403 (dishonest misappropriation of property), 406 (criminal breach of trust), and 34 (common intention) against Shetty, Kundra, and another person.
