Central Bank agriculture credit outreach camp held

Chennai, Nov 15: The Central Bank of India, Chennai Zone, successfully organized a major Agriculture Credit Outreach Camp on Thursday across its 323 branches in Tamil Nadu, Kerala, and the Union Territory of Puducherry. The initiative saw strong participation from farmers, agri-preneurs, Self-Help Group (SHG) members, and rural customers, reinforcing the bank's commitment to expanding agricultural credit access.

At the Coimbatore Regional cluster event held in Dharmapuri, R. Rathinam, Joint Director of Agriculture, Government of Tamil Nadu, and Vasti Venkatesh, General Manager (Treasury) from the bank's Mumbai head office, attended the event along with K. Shashidhar, Zonal Head (Chennai), S. Ramajayam, Lead District Manager (Dharmapuri), and Jyothi Prakash, Regional Head (Coimbatore). Nearly 300 farmers and customers participated, and sanction letters were distributed to beneficiaries.

In the Melmaruvathur cluster under the Chennai Region, the outreach programme held at MAPIMS College drew enthusiastic participation from 300 farmer beneficiaries. Collector inspects teacher qualification exam

Ranipet,Nov15: Ranipet District Collector Dr. J. U. Chandrakala, I.A.S., visited the L.F.C. Girls Aided Higher Secondary School in Ranipet today (15.11.2025) to inspect the ongoing conduct of Paper-I of the Graduate Teacher Eligibility Examination organized by the Department of School Education. For this examination, one question paper custody centre and seven examination centres, including the Government Girls Higher Secondary School in Arcot, GVC Aided Higher Secondary School in Arcot, Sri Ramakrishna Matriculation Higher Secondary School in Arcot, L.F.C. Girls Aided Higher Secondary School in Ranipet, V.R.V. Girls

Aided Higher Secondary School in Ranipet, Government Boys Higher Secondary School in Arcot, and Government Boys Higher Secondary School in Walajapet, were arranged with full security measures. A total of 1,945 candidates are appearing for the examination.

To ensure the smooth and fair conduct of the exam, seven headmasters and seven postgraduate teachers have been appointed as chief invigilators and departmental officers, while 102 teachers have been deployed as hall invigilators and 14 teachers have been assigned as members of the static squad. For candidates with disabilities, five scribes have been arranged. All examination halls have been

equipped with surveillance cameras to closely monitor the proceedings. Police personnel have been deployed at every centre to maintain security, and uninterrupted power supply has been ensured throughout the duration of the examination.

Essential amenities, including drinking water and adequate restroom facilities, have been provided for the candidates. In addition, Revenue Department officials have been appointed as flying squad members to supervise the examination process. District Chief Educational Officer Mrs. Mohana also accompanied the Collector during the inspection.
