Subject: Imposition of penalty on Mr. Kamlesh Jain, Promoter of the Company & Jain Family Trust (through its trustee Mr. Kamlesh Jain) vide Adjudication Order of SEBI in the matter of insider trading activities of certain entities in the scrip of Refex Industries Limited

Dear Sir(s)/ Madam,

We hereby inform that we have been informed today (i.e. December 16, 2025) by Mr. Kamlesh Jain, Promoter of the Company, that the Securities and Exchange Board of India ("SEBI"), has passed an adjudication order bearing reference no. Order/JS/YK/2025-26/31830-31832 dated December 12, 2025, in the matter of insider trading activities of in the scrip of Refex Industries Limited, in exercise of powers conferred under Section 15-I of the SEBI Act, 1992 read with rule 5 of the SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995.

Pursuant to the said order, the Adjudicating Officer of SEBI has imposed a penalty amounting to ₹25,00,000/- (Rupees Twenty Five Lakh Only) under Section 15G of the SEBI Act, 1992, on Mr. Kamlesh Jain, Promoter of the Company & Jain Family Trust (through its trustee Mr. Kamlesh Jain).

We have been informed by Mr. Kamlesh Jain & Jain Family Trust (through its trustee Mr. Kamlesh Jain) that they intend to contest their position and appeal against the above said order. They have also informed that they believe that they can strongly defend the same through the legal process and would avail appropriate recourse available under law, against the adjudication order.

The said order does not have any impact on the financial position, business, or operations of the Company, as the matter pertains to the Promoter and his family trust in their personal capacity. Also, the said order pertains to the show cause notice issued by SEBI on the subject matter which has been duly disclosed by the Company in its offer document for the Initial Public Offering.
