Dear Sir/Madam,

This is in furtherance to our letter dated December 11, 2025 wherein we had intimated about the receipt of communication/ Show Cause Notice received from the Joint Commissioner, SGST, Corporate Circle-I, Ghaziabad Zone-I, Uttar Pradesh for Goods & Services Tax, Interest and Penalty under Section 74 of the CGST/ SGST Act, 2017 for the financial year 2022-23.

We would now like to inform that, following the submission of our response along with necessary supporting documentation, the Tax authority has **revised the initially determined tax liability**, resulting in a **reduced amount payable** as compared to the initially determined figure. The demand amount payable has been reduced from **Rs. 988.43 Lacs** to **Rs. 82.76 Lacs** resulting in a **reduction in Tax liability**. The revision amount includes Tax amounting to Rs. 32,10,830/- Interest amounting to Rs. 18,54,188/- and Penalty amounting to Rs. 32,10,830/-

The order was received by the Company on December 15, 2025 and after reviewing the same the Company is filing the intimation to the Stock Exchange under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

While the Company acknowledges the receipt of the order with reduced tax liability, however, the Company is of the view that certain aspects of the assessment require further review and clarification. Accordingly, the Company intends to file an appeal before the appropriate appellate authority within the prescribed time limit under the GST Act. Necessary steps are being initiated to prepare and submit the appeal documentation

The details as required under Regulation 30 of the SEBI Listing Regulations is attached as **Annexure – A**. There is no material impact on financials, operations or other activities of the Company.
