UPON hearing the counsel the Court made the following
O R D E R

1. Delay condoned.
2. Issue notice, returnable on 24.02.2026.
3. Mr. Arvind Kumar Sharma, AOR accepts notice on behalf of respondent - Directorate of Enforcement.
4. Counter affidavit, if any, be filed within four weeks and the rejoinder, if any, be filed within two weeks thereafter.
5. SLP(Crl.) Nos.2756-2757/2015, SLP(Crl.) Nos.656-657/2022, SLP(Crl.) No.3360/2022, SLP(Crl.) No.3981/2022 and W.P.(Crl.) No.120/2012 and connected matters, if any, are directed to be listed along with these matters on the date fixed.
6. The Registry is directed to notify the next date of hearing to the parties in advance. The Registry shall also put up the file before Hon'ble the Chief Justice of India for constitution of a three-Judge Bench.
7. Meanwhile, operation of the impugned judgments and orders dated 17.10.2025 and 03.11.2025 as well as that of the learned Single Judge dated 19.07.2022 and 24.01.2023, shall remain stayed subject to the condition that the petitioners will furnish an undertaking before this Court within two days to the effect that

they will not alienate the subject properties in any manner and shall not create any third party rights in such properties without prior permission of this Court. However, *status quo re:* further proceedings before the Adjudicating Authority shall be maintained.
