**Subject: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Filing of Writ Petition before the Hon’ble High Court of Madhya Pradesh, Jabalpur Bench, bearing Writ Petition No. 2276 of 2026 to recover the amount from sellers of land parcel situated at Village Shivrajpur, District Chhatarpur**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that **Jungle Camps India Limited (“the Company”)** has filed a writ petition before the Hon’ble High Court of Madhya Pradesh, Jabalpur Bench, bearing **Writ Petition No. 2276 of 2026**.

The said writ petition has been filed against the sellers of a land parcel situated at **Village Shivrajpur, District Chhatarpur**, Madhya Pradesh seeking recovery of the amount paid by the Company towards purchase consideration and seeking appropriate directions including debit freeze of the sellers’ bank accounts. The petition has been filed on account of alleged cheating, criminal breach of trust, and concealment of material facts relating to the title and litigation status of the said land parcel, which was acquired by the Company for business expansion purposes.

The Company has initiated the said legal proceedings to protect its interest and recover the consideration amount paid. The Company is also exploring all other legal remedies available to safeguard the interests of its shareholders.
