1. To Issue Bonus Equity Shares:

To ratify the member's resolution passed on 2nd March, 2023 for issue and allotment of Bonus Equity Shares by passing with or without modification(s), the following resolution as **Special Resolution**:

1. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 which sets out details relating to Special Business to be transacted at the meeting is annexed hereto.
2. In accordance with the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") vide General Circulars Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021, December 8, 2021 and recent MCA Circular No. 10/2022 dated 28th December 2022 (hereinafter collectively referred to as the "MCA Circulars") and any other applicable provisions of the Laws and Regulations including any statutory modification(s) or pre-enactment thereof for the time being in force and as amended from time to time, physical attendance of the Members to the EOGM venue is not required and general meeting be held through video conferencing (VC) or other audio visual means (OAVM). Hence, Members can attend and participate in the ensuing EOGM through VC/OAVM.
3. 15. Shareholders/Investors are advised to send their queries/complaints through the e-mail id gcmil1995@gmail.com for quick and prompt redressal of their grievances.
16. In compliance with the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended by the Companies (Management and Administration) Amendment Rules, 2015 and the provisions of Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, the Members are provided with the facility to cast their vote electronically only. The Company has engaged the services of National Securities Depository Limited (NSDL) for the purpose of providing e-voting facility to all its Members.
- ii. The Company has approached NSDL for providing e-voting services through our e-voting platform. In this regard, your Demat Account/Folio Number has been enrolled by the Company for your participation in e-voting on resolution placed by the Company on e-Voting system.
- iii. The Members who have cast their vote by remote e-voting prior to the EOGM may also attend/ participate in the EOGM through VC / OAVM but shall not be entitled to cast their vote again.
- iv. The Members present in the EOGM through VC / OAVM facility and have not cast their vote on the Resolutions through remote e-voting, and are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the EOGM.
- v. **The e-voting/remote e-voting will commence from Wednesday, April 5, 2023 at 9.00 AM and will conclude on Friday, April 7, 2023 at 5.00 PM.** The remote e-voting module shall be disabled by NSDL for voting thereafter. How to cast your vote electronically on NSDL e-Voting system?

- After successful login at Step 1, you will be able to see all the companies "EVEN" in which you are holding shares and who's voting cycle and General Meeting is in active status.
- Select "EVEN" of company for which you wish to cast your vote during the remote e-Voting period and casting your vote during the General Meeting.
- Now you are ready for e-Voting as the Voting page opens.
- Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on "Submit" and also "Confirm" when prompted.
- Upon confirmation, the message "Vote cast successfully" will be displayed.
- You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
- Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

General Guidelines for shareholders

3. Alternatively shareholder/members may send a request to evoting@nsdl.co.in for procuring user id and password for e-voting by providing above mentioned documents.

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. EXPLANATORY STATEMENT IN RESPECT OF SPECIAL BUSINESS:

(Pursuant to Sec.102 of the Companies Act, 2013)

Item No. 1:

Background of Passing Ratification Resolution

Board of Directors of the Company, at their meeting held on 27th January 2023, has approved the issue of Bonus Equity Shares in the ratio of 1:1 i.e. One Equity Share for every One Equity Share held by Members at record date to be determined by the Board/Committee.

The Company has approached to BSE seeking their in-principle approval for issue of Bonus Equity Shares and to determine record date for issue of Bonus Equity Shares. During the course of approval, BSE has observed that the Company is having revaluation Reserves (including Special Reserves as per RBI Act) of Rs. 9.394 Crore and the same cannot be utilized for issue of Bonus Equity Shares as per prevailing Act, Rules and Regulations.

The Company has taken note of the above BSE observation and have approached to competitive authorities for verification of the same and found that the observation of BSE seems to be true and correct.

Since the Company cannot go take back the Resolution of issue of Bonus Equity Shares; once the Resolution is approved by Board/Members of the Company. Now it has become the responsibility of the Company to issue and allot Bonus Equity Shares in such a ratio which is allowed or admissible under various law, rules and regulations and also can be accepted and approved by the BSE.

In view of the above, the Company is seeking approval of Members for change in terms/ratio of issue of Bonus Equity Shares and to ratify the earlier Resolution passed by Members on dated 2nd March 2023, pertaining to issue of Bonus Equity Shares.

Issue of Bonus Shares:

- 1) Since inception of the Company in 1989, during past 33 years of its operations, has accumulated revaluation Reserves to the tune of Rs.16.94 Crores which can be utilized for issue of Bonus Equity Shares (as on 31.12.2022) with a capital base of Rs.24.8935 Crores.
- 2) Considering the strong reserves and financial position of the Company, the Board considered, approved and recommended issue of fully paid-up Equity Shares as Bonus shares in the ratio 10:6 (i.e. adjusted for Sub-Division of Equity Shares) as on the Record Date (to be determined by the Committee constituted by the Board) by capitalizing Rs. 14,93,61,000 (Rupees Fourteen Crore Ninety Three Lakh Sixty One Thousand only) of the Company.
- 3) The proposed issue of Bonus Shares will be made in accordance with the provisions of Section 63 of the Companies Act 2013, Securities Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations 2018 and Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015/2023, subject to approvals, if any, from the other appropriate authorities. As per Articles of association of the Company, the Company can issue Bonus Shares by capitalization of reserves after obtaining approval of the members.
- 4) The Board of Directors of the Company at its meeting held on March 17, 2023, has constituted a Committee, consisting of three Directors to (i) fix the record date for Sub-Division of Shares and allotment of Bonus Shares (ii) to allot the Bonus shares to the members eligible on the Record Date in the ratio approved by the Members by way of Postal Ballot Rules and (iii) and to do all the things necessary in connection with implementation of Resolutions set out in the Notice for Sub-Division of Equity Shares (Postal Ballot Notice dated 17th January 2023) and issue of Bonus Equity Shares.
- 5) Details of the Authorized, Issued, and Paid-up share Capital of the Company before and after (i) Sub-division and (ii) issue of Bonus shares are as follows:
