Bhavnagar, In Bhavnagar district, a large number of workers are earning their living from the diamond industry after farming. However, after the Diwali holidays, work in the diamond industry usually starts from eleven o'clock on the auspicious day of Labh Pancham, but this year the effect of the recession is still being seen. Currently, there is an atmosphere of sluggishness in the diamond markets. The factories and diamond offices that should have started after Diwali have not even given the auspicious time yet. Due to the severe recession, these units have not yet become fully operational. Currently, only 10 to 20 percent of diamond offices and 30 to 35 percent of diamond factories in the district have opened, which makes it clear that the diamond industry.

a state of recession. After the Diwali festival, the

diamond industry usually resumes its normal activities on the auspicious occasion of the eleventh day of the month, but this year the diamond industry in Bhavnagar district is witnessing a state of recession. About 1.5 to 2 lakh people are employed in the approximately 3 to 4 thousand diamond offices and factories in the city, yet most of the units are currently closed and the markets have not started. The Russia-Ukraine war that has been going on for the last three years and the impact of American tariffs have had a huge impact on the industry. It was expected that the diamond markets would revive after Diwali, but so far no special impetus has been seen. I will be able to start with 50% staff: Manufacturing

Regarding this, diamond manufacturer Bharat Bhayani has said that in the market, it is like this that for the last three years, after the Russia-Ukraine war, the Israeli war started. The market was growing and coming out of it a little, and due to the tariffs imposed by the Americans, the market has completely stopped. I am also a manufacturer. I myself have not started my units yet. My plan is that I will be able to start with 50% staff. My plan is after Diwali. We are working hard to provide full employment, but there is no support from the market.

The auspicious times that are supposed to happen on the 5th and 11th have not happened yet: Diamond trader Satishbhai Mandani said that I have been involved in the recession is still affecting the diamond business for the last many years, i.e. since 2003. In The diamond industry is in the last three to four years, after the Russia-Ukraine war. there has been a continuous slow-down and currently.
