

Shaheen used SIM card obtained on a fake address

The ongoing probe into the Delhi blast has revealed that the suspected member of Jaish-e-Mohammed module, Dr Shaheen Sayeed, had been using a SIM card obtained on a fake address for a long time.

She had obtained a SIM card on the address of a mosque in Faridabad's Dhouj town and had been continuously using it from the Al-Falah University hostel.

Her travel history, frequent UP connections, and recent activities in Lucknow and Kanpur Nagar have further increased security agencies' concerns. The UP Anti-Terrorism Squad and

intelligence teams are now working to trace her movements.

It surfaced that Dr Shaheen operated her network using the mosque's address. During the investigation, the UP ATS and central agencies found that Dr Shaheen extensively used the mobile phone number, SIM card for which was obtained in 2023 by submitting fake documents.

Dr Shaheen, who was living in the Al-Falah University hostel, had a real address in Lucknow, but she neither provided the address of her father's home in Lucknow nor any valid identification documents. It is clear that she deliberately concealed her original address.

The investigation has also



revealed that Dr Shaheen did not mention her real home address in Lucknow in all her documents and official records. While filling the forms, she used to mention her brother Dr Parvez Ansari's house as her permanent address. The investigating agencies believe that this could be a part of her strategy to maintain the secrecy of her network and travel history.

The role of Dr Parvez is also on the radar of the agencies.

It further surfaced that Dr Shaheen traveled to Thailand after leaving her job in Kanpur. Her travel history has further complicated the investigation. Records reveal that she traveled to Thailand for a few days in 2013, shortly after leaving her job in Kanpur.

The investigating agencies are examining the timeline of her trip to Thailand and her contacts. During this time, sleeper modules of several teractive in Southeast Asia.

About two months ago, Dr Shaheen suddenly came to Lucknow and took her brother Dr Parvez to Kanpur. The investigators are finding the persons with whom she met, the place of stay, and persons with whom she was in contact with.

The UP ATS believes that her trip to Thailand may have some specific purpose, and electronic surveillance and location dump data are being examined to uncover this. The UP ATS and intelligence teams are busy unraveling her network.

The investigation of Dr Shaheen's electronic devices, banking records and contacts has been intensified.


