**Subject: Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015 – Fine imposed by BSE for one-day delay in filing RPT under Regulation 23(9)**

Dear Sir/ Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that BSE Limited has imposed a fine of ₹5,000 for a one-day delay in submission of the Related Party Transactions (RPT) disclosure in XBRL format for the half year ended 30th September, 2025, under Regulation 23(9) of the SEBI (LODR) Regulations, 2015.

The delay was technical in nature and occurred due to a change in filing requirements pursuant to BSE Circular dated 2<sup>nd</sup> April, 2025, which mandated integrated Financials XBRL filing (now including RPT disclosures) on the same date as declaration of financial results. Earlier, XBRL results were permitted to be filed within 24 hours of approval. The fine has been paid, and the Company will be more vigilant in meeting regulatory timelines to avoid recurrence of such delays.

The details required under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular CIR/CFD/CMD/4/2015 dated 9<sup>th</sup> September, 2015 and SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/ 120 dated 11<sup>th</sup> July, 2023 are enclosed as **Annexure A**.
