Sub: Outcome of the Board Meeting of the Company held on Tuesday, 18th March 2025

Dear Sirs/Madam,

We wish to inform you that the Board of Directors at its meeting held today i.e., Tuesday, 18th March 2025, *inter-alia*, considered and approved the following:

- Convening of the Sixty Nineth (69th) Annual General Meeting of the Company on Thursday, 15th May 2025 at 3:30 p.m. through Video Conferencing / Other Audio-Visual Means (VC/ OAVM).
- 2. We refer to our intimation dated 27th February 2025, informing that the Board, at its meeting held on 27th February 2025, had recommended a final dividend of ₹ 117/- per equity share of the face value of ₹10 each for the Financial Year ended 31st December 2024, subject to the approval of Shareholders at the ensuing 69th Annual General Meeting.
 - In the above context, payment of the Final Dividend will be made to those members whose names are on the Company's Register of Members on **Friday**, **25**th **April 2025** ("Record Date") and those whose names appear as Beneficial Owners as at the close of the business hours on **Friday**, **25**th **April 2025** as per the details to be furnished by the Depositories, viz. NSDL and CDSL, for this purpose.
- 3. The Board, based on the recommendation of the Nomination and Remuneration Committee, have approved the re-appointment of Mr. Rahul Bhatnagar (DIN: 07268064) as an Independent Director of the Company for a second term of five consecutive years starting from 29th July 2025 to 28th July 2030. The current term of Mr. Rahul Bhatnagar as an Independent Director of the Company is set to conclude on 28th July 2025. The said reappointment is subject to the approval of the Members through special resolution at the ensuing 69th Annual General Meeting of the Company.



Mr. Rahul Bhatnagar has submitted a declaration that he meets the criteria for independence as provided under Section 149(6) of the Act and Regulation 16(1)(b) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. He has also confirmed that he has not been debarred from holding the office of Director by virtue of any Order passed by the Securities and Exchange Board of India or any other such authority.
