New Delhi: Energy giant Shell has told the government that separating gas marketing and transportation business in the country will provide a level

playing field to other gas suppliers and boost gas demand in India. "The experiences of developed gas markets globally have demonstrated that for gas markets to be competitive, gas transmission and marketing businesses need to be unbundled," Shell India chairman Nitin Prasad wrote to the oil ministry two weeks ago. "This will ensure non-discriminatory access to the network and deter vertically integrated companies from taking undue advantage of their monopolistic position, thus preventing conflicts of interest.

Shell India, in a joint venture with Total, owns a natural gas import terminal in Gujarat and markets gas besides being active in other segments.

Shell's Prasad didn't clarify if his firm has faced any discrimination in accessing natural gas pipelines in the country.
