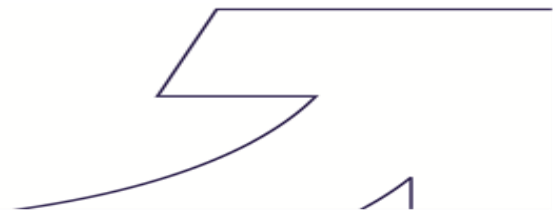
Respected Sir,
