# Demand recovery to drive Nestle India's gains

Beverages segment contributed to robust Q2 growth

Packaged food major Nestle India posted better than expected September-quarter results, led by strong volume growth across its key segments. While there were margin pressures due to elevated raw material costs, there could be some relief with easing prices in the near term. the near term.

some relief with easing prices in the near term.

Brokerages are positive on the stock from along-term perspective. An improving demand environment and recent goods and services tax (GST) reforms are expected to boost consumption going ahead. While there are growth triggers, the stock may not see a sharp uptick given valuations. The third-largest listed consumer company by market capitalisation is valued as over 76 times its 2025-26 (TV26) earnings estimates, and 63 times its FY27-estimates.

The firm posted a revenue growth of 100 per cent year-on-year (Y-o-Y), led by robust double-digit growth of confectionery, beverages.

growth of 10.6 per cent year-on-year (Y--Y), led by robust double-digit growth of confectionery, beverages, and prepared dishes segments. While the beverages segment was the keygrowth driver, the milk products and nutrition category delivered a mixed performance. Some segments reported strong growth while others lagged. In prepared dishes, double-digit volume growth for Maggi nootles was led by market share gains in rural areas. In the confectionery seg-ment, growth was led by Kilstat due to market share gain and distribu-tion expansion in rural areas, with Munch and Milk byar also growing in high double-digit. Though revenue growth was strong the margin performance was muted, with gross margins falling 230 basis points (bps) Y-O-Y and 80 bps quarter-on-quarter (Q-O-1) to 54.3 per cent while estimates had placed it above 55 per cent. The pressure was on account of higher aw material costs. The company, however, indicated that edible oil prices could stay higher while milk prices care likely to come down. Coffee and cocca prices are expected to remain range-bound (eiven the margin pressures at the Afficial Case and Company due to the prosecution of the procession of the procession

Demat required, pay annual fee Buyers need a demat account to invest in gold ETFs. "Gold ETFs involve annual management fees and may have slight tracking errors," says Yadav. (Tracking error refers to the difference between the ETF's actual returns and the returns of the asset it aims to replicate.) Vira points out that possible bid-ask spreads in thinly traded ETFs can raise transaction costs. Investors also have to pay a brokerage fee
