Sub: Outcome of Board Meeting held on November 18, 2025

Pursuant to Regulation 30 read with para A, part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform you that the Board of Directors of the Company, based on the recommendations of the Nomination and Remuneration/Compensation Committee (NRC), at its meeting held on November 18, 2025 has approved the following:

- A. Amendment in Superannuation policy of the Company for Senior management keeping in view the Succession plan and to ensure retention and continuity in critical leadership positions as follows:
 - a. The superannuation age for the Chief Executive Officer (CEO) shall be 63 years, in modification to the standard retirement age of 58 years.
 - b. The superannuation age for Key Managerial Personnel (KMP), Senior Management (apart from CEO) and other critical positions (as may be decided by NRC) shall be 62 years, in modification to the standard retirement age of 58 years.

These extensions of Superannuation age shall be considered on a discretionary, case-to-case basis, for the above-mentioned positions, subject to approval by the Nomination and Remuneration/Compensation Committee (NRC) and the Board of Directors upon completion of the standard retirement age of 58 years.

B. Re-appointment of Mr. Parag Bhise (DIN: 08719754) as a Whole-Time Director and CEO of the Company for a further period of 2 year with effect from April 01, 2026, to March 31, 2028, subject to approval of the Shareholders of the Company.

Further, pursuant to BSE Circular No. LIST/COMP/14/2018-19 and NSE Circular No. NSE/CML/2018/24 dated 20 June 2018, he has not been debarred from holding the office of Director by virtue of an order of the SEBI or any other such authority.
