We, WestBridge AIF I, being a promoter of the Company, are writing to request the Company to do the needful as required in accordance with Regulation 31A of the SEBI LODR Regulations, to reclassify the entities listed below from the 'Promoter/ Promoter Group Category' to the 'Public Category':

- 1) Ebono Private Limited; and
- 2) G S E-commerce Private Limited ("Design Cafe", and together with Ebono Private Limited, the "PG Entities").

The Company will recall that the PG Entities were disclosed as part of the 'Promoter Group' of the Company in the Company's Prospectus dated December 07, 2021 for the Initial Public Offering of equity shares of the Company, and continue to be noted as part of the 'Promoter Group' in the shareholding pattern filed by the Company with the BSE Limited and National Stock Exchange of India Limited in accordance with the SEBI LODR Regulations.

On account of WestBridge AIF I holding more than 20% (twenty per cent) of the equity share capital of each of the PG Entities, the PG Entities were classified as part of the 'Promoter Group' in accordance with Regulation 2(1)(pp) (iii) of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("SEBI ICDR Regulations"). Please note that WestBridge AIF I no longer holds more than 20% of the equity share capital of the PG Entities.

In light of the above, we request the Board of Directors of the Company to take all necessary steps for the reclassification of PG Entities from 'Promoter Group' category to 'Public' category in accordance with Regulation 31A of the SEBI LODR Regulations and have them deleted from the shareholding pattern filed by the Company with the BSE Limited and National Stock Exchange of India Limited in accordance with the SEBI LODR Regulations
