## HPCL empowers 28 startups with Rs 27 crore investment: Hardeep Puri

New Delhi, May 17 (IANS) Hindustan Petroleum Corporation Ltd. (HPCL) is fueling the Indian startup ecosystem, and has invested Rs 27 crore to empower 28 startups to date, Hardeep Singh Puri, Union Minister for Petroleum and Natural Gas, said on Saturday.

"Thanks to Prime Minister Narendra Modi's Startup India initiative, which continues to fuel innovation across the country," he added.

## South Korea holds bilateral trade talks with 14 partners at APEC meeting

Seoul, May 17 (IANS) South Korea has discussed ways of enhancing bilateral economic and trade cooperation with the United States, China, Japan and several other partner nations on the sidelines of the Asia-Pacific Economic Cooperation (APEC) meeting amid heightened uncertainties in the global economic and trade landscape, the industry ministry said.

The two-day APEC Ministers Responsible for Trade Meeting took place on South Korea's southern resort island of Jeju from Thursday, providing an opportunity for trade ministers of regional economies to engage in one-on-one discussions, according to the Seoul's Ministry of Trade, Industry and Energy, reports Yonhap news agency.

On the sidelines of the meeting, South Korean trade and industry officials held high-level bilateral talks with representatives from 14 of the 20 other APEC member economies, as well as with the director-general of the World Trade Organisation (WTO), to explore avenues for trade cooperation and coordination.

"During my meeting with U.S. Trade Representative Jamie Green yesterday, I explained the current political situation and other domestic issues ahead of the upcoming presidential election. We also reviewed the procedures necessary to conclude the negotiations," Trade Minister Cheong In-

kyo said during a press briefing. Industry Minister Ahn Duk-geun is scheduled to meet with Greer later in the day, which "is expected to be a chance for the two sides to understand each other's positions during these two rounds of tariff talks," he added. Last month, the Donald Trump administration began imposing reciprocal tariffs on partner nations, including 25 percent duties on South Korea, only to pause them shortly afterward to allow for one-on-one negotiations.

Seoul and Washington subsequently agreed to work toward a "July package" deal on trade and other related issues before July 8, when Trump's 90-day pause on reciprocal tariffs is to expire.

Cheong met with senior officials from Japan's economic and foreign ministries on Jeju, where the two countries agreed to enhance cooperation in advanced industries, hydrogen and other new energy sectors, and supply chains, according to the ministry. In a separate meeting with his Indonesian counterpart, Cheong requested active support for South Korean companies operating in the Asian nation. "The government will make every effort to mitigate uncertainties in the trade environment and external risks by further strengthening the foundation for cooperation with the Asia-Pacific region," the ministry said in a statement.—IANS

### DPIIT, GEAPP partner to boost opportunities for clean energy startups in India: Official

Mumbai, May 17 (IANS) The Department for Promotion of Industry and Internal Trade (DPIIT) has signed a Memorandum of Understanding (MoU) with the Global Energy Alliance for People and Planet (GEAPP) to enhance opportunities for clean energy startups in India, Ministry of Commerce and Industry announced on Saturday.

Sanjiv, Joint Secretary, DPIIT said the collaboration will help startups scale technologies that support India's long-term net-zero goals.

"India's climate leadership depended on a strong entrepreneurial base. The partnership would open significant opportunities for clean energy startups to scale technologies that support the country's long-term net-zero objectives," he stated.

Under the two-year partnership, both organisations aim to boost innovation, sustainability, and entrepreneurship in the clean energy and manufacturing sectors. The initiative will support early-stage climate-tech startups by helping them access funding, mentorship, pilot projects, and market connections. There is also a provision to extend the partnership beyond the initial term.

### India willing to remove 100 pc tariffs on US goods: Donald Trump

Washington, May 17 (IANS) US President Donald Trump has claimed that India offered to remove all tariffs on American goods, but added that he was in no rush to finalise a trade deal despite the apparent breakthrough.

In an interview with Fox News on Friday, Donald Trump said India is a top example of a country with barriers he is determined to dismantle.

"They make it almost impossible to do business. Do you know they're willing to cut 100 per cent of their tariffs for the United States?" the President said.

But Trump also sent mixed signals on how close a deal could be, saying, "That'll come soon. I'm in no rush. Look, everybody wants to make a deal with us." He added that he is not planning to "make deals with everybody."

However, reacting to Donald Trump's claim that India has offered a trade deal with "literally zero tariffs," External Affairs Minister (EAM) S. Jaishankar on Thursday said that the ongoing negotiations are complex and far from final.

"Between India and the US, trade talks have been going on. These are complicated negotiations. Nothing is decided till everything is. Any trade deal has to be mutually beneficial; it has to work for both countries. That would be our expectation from the trade deal. Until that is done, any judgment on it would be premature," EAM Jaishankar said while speaking to reporters. This indicates that such charges may soon become common across all food delivery platforms. Earlier, Zomato Gold members enjoyed benefits like free delivery and no surge fees during rain. Now, with this new rule, regular users and Gold members will be treated the same during bad weather.

## 600 families along Adayar river bank in Chennai to be evicted next week

Chennai, May 17 (IANS) The Tamil Nadu Water Resources Department (WRD) is set to initiate the eviction of over 600 families residing illegally along the Adayar riverbank in Anakaputhur, starting next week. This move comes nearly a year after eviction notices were first issued. Despite building permanent structures on the river's edge without authorisation, the families had resisted eviction for several months.

The delay was further prolonged by legal challenges in the Madras High Court, which have now been resolved.

A senior WRD engineer confirmed that after extended negotiations with resi-

dents, the Department is now prepared to proceed with the eviction and resettlement process.

The affected families will be relocated to tenements constructed by the Tamil Nadu Urban Habitat Development Board (TNUHDB).

The resettlement sites include Perumbakkam, Thailavaram near Perungalathur, and Keerappakkam, with 200 housing units allotted in each location.

Encroachments in Anakaputhur include settlements in Thai Moogambini Nagar, Quaid-e-Millath Nagar, Shanthi Colony, and MGR Nagar.

With this phase of eviction, WRD officials said nearly 75 per cent of en-
