Reg: Report on the Postal ballot process for the resolutions as set out in the Notice of Postal Ballot dated 14<sup>th</sup> November, 2025.

Sir

1. The board of directors of Bannari Amman Spinning Mills Limited ("the Company") (CIN: L17111TZ1989PLC002476) at its meeting held on 14<sup>th</sup> November, 2025, appointed me as a Scrutinizer to scrutinize the Postal Ballot Process (voting by e-voting) and issue a report in connection with the subject matter.
2. I submit my report as under:
  - a. As per General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 05, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 03/2022 dated May 05, 2022, 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023, 9/2024 dated September 19, 2024 issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India, the Company has sent the Postal Ballot Notice dated 14<sup>th</sup> November, 2025 through electronic mode to the members whose names appeared in the Registrar of Members/list of beneficial owners as on cut-off date i.e 14<sup>th</sup> November, 2025.
  - b. As the Postal Ballot process was conducted only through remote e-voting system pursuant to the above referred circulars, no Postal Ballot forms were required to be sent by the Company.
  - c. Particulars of all votes cast through electronic mode have been entered in the Register separately maintained for the purpose in electronic mode.

- d. Since there was no voting by physical postal ballot form, the question of keeping them in my safe custody before commencing the scrutiny does not arise.
- e. The votes cast through electronic means were unblocked after 5.00 P.M. on 18<sup>th</sup> December, 2025.
- f. Votes cast through electronic means were scrutinized and the shareholding was matched with the Register of Members of the Company / list of beneficiaries as on the cut-off date 14<sup>th</sup> November, 2025.
- g. Votes cast through electronic means up to 5.00 P.M of 18<sup>th</sup> December, 2025, being the last time and date fixed by the company for voting through electronic means were considered for my scrutiny.
- h. Since the voting on Postal ballot Process was conducted only through e-voting, reporting on number of envelopes containing postal ballot form received after due date and up to the date of this report does not arise.
- i. Since the voting on Postal ballot Process was conducted only through e-voting, reporting on number of envelopes containing postal ballot form returned undelivered also does not arise.
- j. Since the voting on Postal ballot Process was conducted only through e-voting, reporting on finding of defaced or mutilated ballot papers also does not arise.
- k. All the e-registers and records relating to e-voting process kept by me be returned to the Company on receipt of proof of signing of the related minutes by the Chairman for their safe custody.
