We hereby inform you that **J. Singh & Associates**, Statutory Auditor of the Company, is constrained to tender our resignation as the Statutory Auditor of **Bizotic Commercial Limited** with immediate effect.

The key reasons for our resignation are as follows:

Resignation of One of the Partners:

A key partner of our firm, who was primarily responsible for overseeing audits of your Company, has recently resigned from the partnership. This has resulted in a significant reduction in our overall audit leadership capacity.

Acute Staff Constraints:

Due to unexpected staff shortages and resource limitations, we are presently unable to allocate the necessary team strength required to ensure timely and quality completion of the audit.

Because of the above circumstances, we will not be in a position to complete the audit within the stipulated timelines prescribed under the applicable laws and regulations. In order to avoid any further delay or inconvenience to the Company, we believe it is appropriate to resign and allow the Company to appoint another auditor who can devote adequate time and resources.

We confirm that there are no other material reasons for our resignation except those stated above. We also confirm that we have provided all information and explanations as required under Section 140(2) of the Companies Act, 2013 read with Rule 8 of the Companies (Audit and Auditors) Rules, 2014.

We place on record our sincere appreciation for the cooperation extended to us during our tenure as the Statutory Auditor of the Company.
