## Allcargo Logistics Expands Reach to Cover 100% of India's PIN Codes with new 'Allcargo Extended Reach (AER)' Network

## Strengthens direct service capabilities with 32,000+ PIN codes, enhances last-mile connectivity across Bharat

**Mumbai, 17**<sup>th</sup> **December 2025** — Allcargo Logistics Limited, post approval of the organisation's restructuring plan, housing its domestic supply chain business; Express distribution and Consultative logistics, has announced a significant transformation of its domestic distribution network with the launch of Allcargo Extended Reach (AER), an upgraded and rebranded version of its earlier Extra Serviceable Stations (ESS).
